Approval of Meeting Minutes

September meeting minutes approved with no changes.

<u>Treasurer's Report—Joan Martin</u>

Joan presented the SHNA budget dated 10/31/21. No concerns about income and expenses for the year so far.

Planning and Development Report—Tom Kneubuehl

- 1) Discussion about the planned Lake Mendota Drive redevelopment project
 - Tom: public meeting scheduled—neighbors will learn about details of project
 - Tom: suggested starting conversation with neighbors as soon as possible to raise awareness
 - Faith: plans are for work in 3 segments, each has own issue
 - Tom: city conversation is about the project as a while
 - Tom: in talking to neighbors, feedback is no sidewalks, or curb and gutters, mark lanes for bike
 - Faith: need to be more organized to have more weight; make neighbors more aware of the details of the project
 - Faith: environmental concerns
 - Tanya: supports starting conversation sooner than later, need to be proactive, suggested providing place and time for neighbors to get together and discuss
 - Tom: will talk to Aaron (Crandall) about approach
 - Janet: agree with what's been said, encouraged that Keith said City is, for the first time, willing to consider an option without sidewalks
 - Aaron: can push for new ideas, if asked for examples from other cities, city staff
- 2) Harbor boat landing/walls
 - Tom: work going on now
 - Faith: meetings with city happened two years ago, neighborhood considerations presented during planning stage. FEMA funded
 - Faith: currently sending emails to city engineering, have been responsive to concerns about bare bones design, ugly looking hard structures, riparians, berms, booms an issue
 - Main issues Faith is seeing—steps, additional culvert outlet will be above water, not fitting into water.
 - Concerned spring flow to help the wildlife
 - 2019 was the last time issues were discussed; Faith is not seeing addressed now
- 3) Degan project on University Avenue (old Perkins site):
 - Parking issues on streets in neighborhood across the street; Parking Enforcement has put up temporary no parking signs to keep workers from parking on both sides of the street

- Spring meeting review—start thinking about agenda and guest speaker now
- Indian Hills neighborhood sign repair—work to be done in April or May 2022, donations continue to come in; sent out Cheddar up update about donations. Aaron will send thank you note to neighbors who made large contribution
