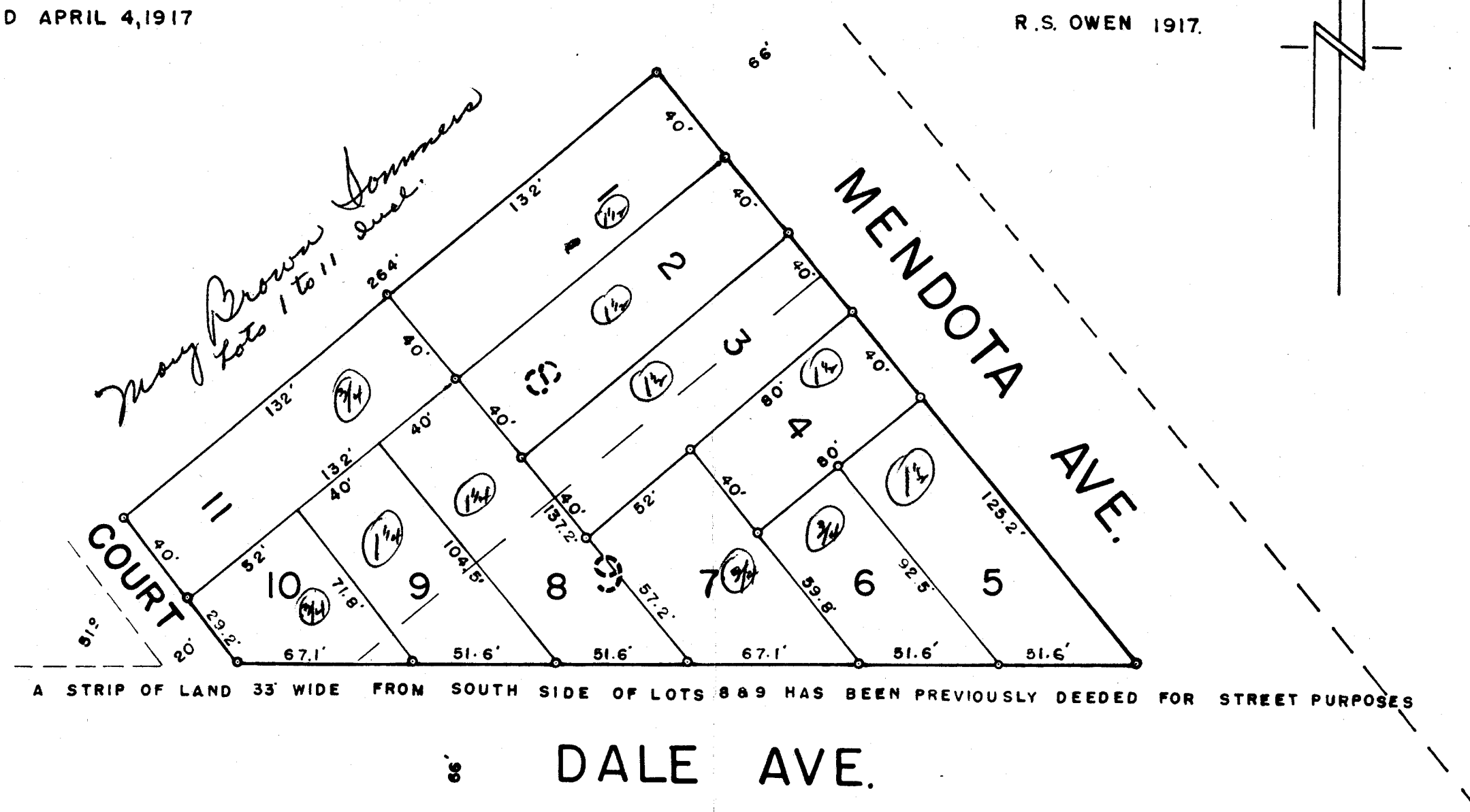

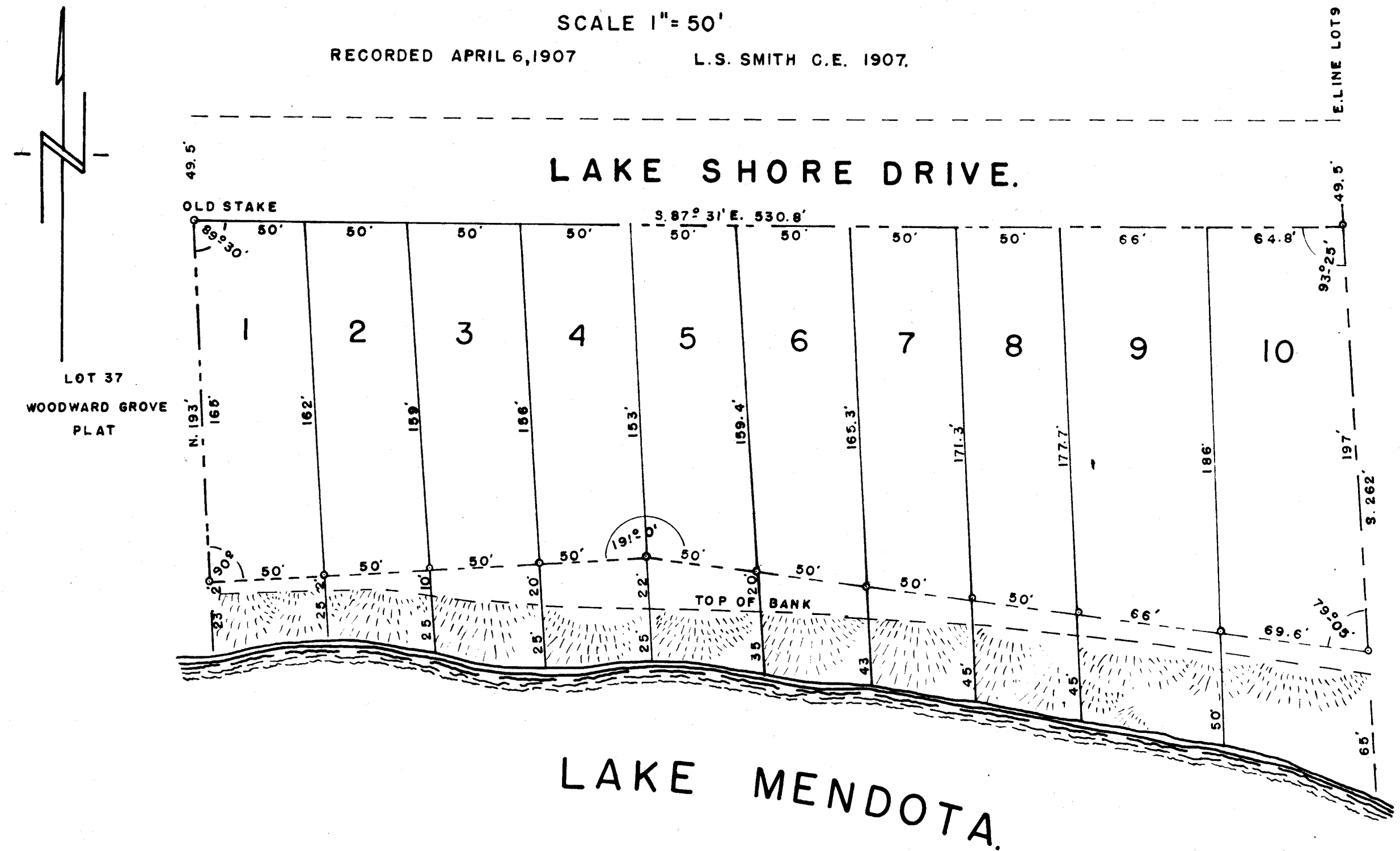
PLAT OF NORTH PARK
