## Fall Membership Meeting

**Spring Harbor Middle School**

### *Proposal For Shoreland Management Planning*

The fall Spring Harbor Neighborhood Association membership meeting is planned for Thursday, October 16, at 7:00 PM. We have invited Brian Standing from Dane County's Department of Planning and Development to present information on the county's Water Body and Shoreland Management Planning projects. These projects, which include new zoning requirements for property within 1000 feet of a navigable water body, would have a major impact on a large proportion of the lots in our neighborhood (and city-wide) if the proposed standards and regulations are applied to urban areas. Under the proposed standards, many of our lots would become non-conforming. We have also invited someone from City of Madison Planning and Development to answer questions and to provide the city's perspective on this plan.

Please read the article on page 5 that explains more about the impact on our neighborhood. You will also find directions on how to access the Dane County website to review the draft of the plan.

At the meeting, we will also hear from our local government representatives, Ald. Mark Clear and Supervisor Brett Hulsey. Of special interest to SHNA residents will be an update on the planned reconstruction of University Avenue. Other items include neighborhood committee reports, an update on the exciting new turtle rain garden planned for next year, and the annual Halloween party.

## Fall Leaf Reminder

Did you see the "Love Your Lakes..." signs around Madison last fall? They are part of a citywide campaign to remind homeowners to keep their raked leaves and yard waste out of the streets and gutters. Decaying leaves provide nutrients for the algae in our lakes (algae are the green, stinky aquatic plants that start to plague our lakes in early summer). When placed in the street, nutrients from the leaves can be leached out by rain or snowmelt, wash down the storm sewers and into the lake, "feeding" the algae and causing them to grow rapidly. The leaves themselves don't have to go anywhere. Leaf pickup is one of the City's largest and most costly projects of the entire year.

The best way to handle leaves is to simply mulch them into your yard with the mower. The nutrients will ultimately soak into the lawn and give a little free fertilizer to the grass. Raked leaves should be placed on the terrace above the curb and NOT in the street. It is illegal to do so, and is punishable by a stiff fine! If you must bag your leaves, leave the bag tops open so collection crews can determine what's inside. Leaves also make a wonderful compost for gardening. Do not mix leaves or yard waste with brush as neither will be picked up if mixed. You may place a tarp over your leaves to keep them from blowing around. Pickup crews will leave the tarps.

The City is scheduled to begin fall leaf pickup on Monday, October 6. You can check a recorded announcement (267-2088), or visit [www.cityofmadison.com/streets](http://www.cityofmadison.com/streets) to find out when leaf pickup crews will be in your neighborhood. ## Dane County Supervisor Report

Dear friends,

Hope you are having a good fall. It was quite a wet June with record rains. On the Lakes and Watersheds Commission, I worked to draw up Clean Lakes Budget Initiatives to reduce flooding, and help clean up our lakes.

Especially important to the Spring Harbor neighborhood are: \$9 million to purchase wetlands that store flood-water and help clean up the lake; \$2 million to upgrade locks to better manage our lake levels; \$300,000 for better modeling to determine where flood and polluted waters are coming from, and much more, see [http://danedocs.countyofdane.com/webdocs/pdf/lwrd/lakes/2009\\_Draft\\_Budget.pdf](http://danedocs.countyofdane.com/webdocs/pdf/lwrd/lakes/2009_Draft_Budget.pdf) for a copy of the proposal.

## Alderman Report

Dear Spring Harbor Neighbors,

It's budget season at City Hall. Here's an update: The Mayor has introduced his 2009 capital budget, which is where we fund major projects. Highlights include funding for a new central library, building fire station #12 on the far west side (which will improve response times to the Spring Harbor area), and a number of road reconstruction projects. Especially important for Spring Harbor, the Mayor's budget includes \$730,000 for starting the University Avenue reconstruction project between Segoe Rd. and the Middleton border. Activities in 2009 include engineering and design work, with a public participation process to determine the look and feel of the street and amenities to be included. Construction would proceed in 2011 as previously scheduled.

The budget also includes \$1.67 million to reconstruct Old Middleton Road between Capital Avenue and the Middleton border. This project would be done in 2009, after a similar public input process.

I have fought hard to get these two items into the budget, and will continue to work to protect them as the budget works through the Council approval process. I know I don't have to tell any of you how much they're needed, both for safety and to preserve and improve the quality of our neighborhoods. Another hurdle that the University Avenue project must pass is a cost sharing agreement for the project with Dane County.

Overall, the Mayor's budget proposes \$76.7 million in borrowing, which is down more than \$16 million from this year. Managing our overall borrowing is crucial to keeping our operating budget (where we pay off the borrowing) in control. I support the Mayor's efforts to reduce borrowing while rebuilding and maintaining our infrastructure.

The Mayor's operating budget for 2009 will be released on October 7. As you've probably read, our operating budget is going to be very tight. The Mayor has asked all departments to provide contingency plans for cuts of up to 5%. For many departments, this would mean devastating many service reductions. If we don't make significant cuts, we will be faced with large tax increases. It will be very difficult to find a balance between preserving vital services and keeping taxes reasonable. What are your priorities? I would very much appreciate your ideas and suggestions.

## Come to the Halloween Party

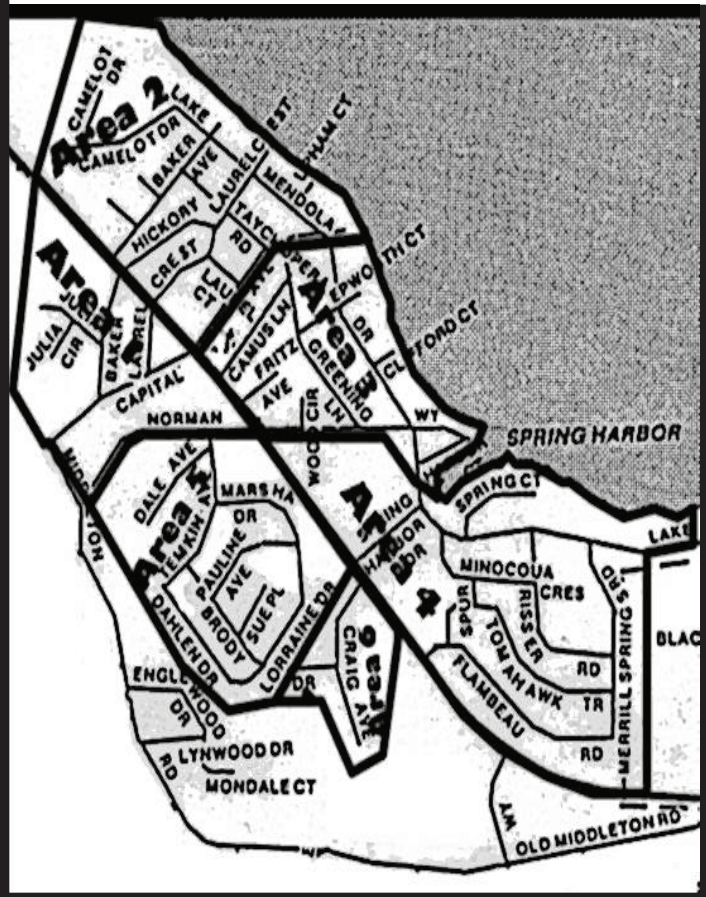

## Dane County's Waterbody Classification Project- Effects On Our Neighborhood

Waterbody Classification Project was undertaken to classify all waterbodies of the county into various categories for regulation and protection and to develop standards for the development and use of all properties within 1000 feet from lakes and ponds and 300 feet from streams and rivers.

Protection and restoration of the waters of Dane County is a goal that most people support. However the proposed regulations will be far reaching. To conform to the rules properties in our neighborhood will require a minimum width of 100 feet and an area of one-half acre. Older lots will not be grandfathered for the purpose of obtaining permits. Note that very few properties in our neighborhood meet even the minimum area standards (there are other minimum standards besides lot area).

Lots that do not meet the standards will be non-conforming and will not be granted building permits without mitigation. The requirements of mitigation are wide ranging, potentially expensive, and may be impossible for some owners.

To obtain a building permit county staff may require mitigation measures with a wide range of changes to the lot including steps such as changing the color of the house, demolishing accessory buildings (sheds, garages, boathouses), changing the vegetation on the lot, changing the use of parts of the lot (converting lawns to other plantings, remove patios), and other measures.

Many comments on the proposed classification standards have been sent to the county including objections from the City of Madison, other cities, townships, and business groups questioning the appropriateness, effectiveness, and necessity of applying these regulations on dense older urban areas. Others have pointed out that the impact of storm water runoff on our lakes and rivers is not just due to properties in the shorelands. All lots served by storm sewers generate runoff that affects the waters of Dane County not just those within 1000 feet of the lakes.

The proposed regulations will affect thousands of properties (estimated at 40,000 to 50,000 non-conforming properties) whose owners are most likely unaware of the classification study and Shoreland Management Plan.

The SHNA Board has asked that the county notify all affected owners and make them aware of the potential impact to them and provide an opportunity to participate in the process. In addition we believe that given the wide ranging impact of the proposed regulations that the county should do a thorough impact analysis on current and future development and determine the cost of these changes on property owners.

## Lake Mendota Drive Turtle Rain Garden



A committee of members from the Indian Hills Garden Club and Spring Harbor Neighborhood Association are working on replacement garden plans for the traffic island at the intersection of Lake Mendota Drive, Minocqua Crescent, and Spring Court. The innovative plans include a rain garden around the storm sewer, a catch basin for sediment coming off the road during snowmelt runoff, and a kid-friendly turtle shaped garden of native grasses rising out of the rain garden. We are planning on sharing costs with the City Parks and Engineering Departments. In addition, City Engineering has graciously offered to apply for Dane County stormwater grants for this project next spring.

We believe that the project will be not only a beautiful addition to the city and neighborhood but also provide an environmental benefit by reducing sand sedimentation and treating stormwater before it enters Lake Mendota.

We ask for your input and support of this important project as we further develop the plan. Donations, either through Indian Hills Garden Club or Spring Harbor Neighborhood Association, are appreciated. We hope to begin construction in the spring or fall of 2009 (dependent on funding and least disturbance to the existing oaks).
